fastening system: by means of laces;

processing: direct injection;

outsole: black rubber marked "SAFETY VERA GOMMA HRO OIL RESISTANT ANTISTATIC MADE IN ITALY ABS ANTISHOCK", (cod. 2137BCP/00 022/ 1/00);

midsole: coffie-colored foamed PU (cod. MPI/001);

scuff-resistant covering of the toe region: made of the same material of the midsole;

<u>upper</u>: black leather DAKAR TREKKING IDRO declared thickness 2,0/2,2 mm (cod. DAI/NER), with inserts in the heel area made of grey retro-reflective material MOON LIGHT (cod. MOX/47)with a reinforcement in the heel area in black polymeric material SUPPORT SYSTEM (cod. G016NG);

<u>collar</u>: fabric VANCOUVER in black color 4017 with a white hatching matched with PE40 (cod. VAA/4017);

tongue/bellows: simple fabric VANCOUVER in black color 4017 with a white hatching (cod. VAN/4017), lined and centrally padded;

<u>vamp and rear lining</u>: fabric SPOTEX TEPOR SELENE in black color (cod. SPO/SELN), which covers the insole;

collar lining: fabric AT 488 SPECIAL in black fabric (cod. A8S/NER);

<u>insole</u>: white multi-layered fabric ZP01/1500 (cod. LC/ZP01) covered by the <u>lining</u>, <u>which</u> also serves as penetration resistant insert;

removable insock: black foam material matched with non-woven fabric in contact with the foot, perforated in the forepart, with an aluminum insert stitched with antistatic thread (zigzag stitching), and an insert in piglet nabuk leather in otter-like color (cod. CIF/LON) stitched in the heel area in contact with the foot (cod. FLNPLCA);

toecap: in perforated and reinforced steel article 604FR (cod. 604ACRF).

Functions and performance levels:

basic requirements for safety footwear (see Table 2 and 3 of EN ISO 20345:2011): all mandatory ones, among which:

**SRC** = Slip resistance – meets the following requirement:

- <u>surface</u>: ceramic / <u>lubricant</u>: detergent solution;
- <u>surface:</u> steel / <u>lubricant</u>: glycerol.

Additional requirements (Tab. 18 and 20 of EN ISO 20345:2011):

**S3** = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil, water penetration resistance and absorption (water-repellent upper), penetration resistance, cleated outsole; **HRO** = resistance to hot contact of the outsole; **HI** = heat insulation of sole complex; **WR** = resistance to water penetration of the whole footwear.

Note: the penetration resistance of the synthetic stitch proof insole tends to decrease with the diameter of the perforating object; in return the synthetic insole offers more protective surface and ergonomics advantages (flexibility, insulation, humidity and impact absorption).

- Name of the Manufacturer (on the external side of the footwear);
- designation, unique and unambiguous, of the footwear;
- nr. and year of the Standard of reference + safety symbols;
- size of footwear (printed also into the outsole);
- production date (month + year);
- additional information: internal codes.
